Establishment of Vision Centres:

Vision Centre plays an important role in increasing access of rural and underserved communities to primary eye care services. During this quarter, supported by SEVA Foundation 3 more vision centres with teleconsultation facilities were established in the operational areas of MNC. On 1st July 2024, the Vision Centre at Laikera of Jharsuguda district was inaugurated by Sri Prasanta Kumar Naik, Chief Executive, LEpra Society. Sri Prasanta Kumar Naik expressed his pleasure over the offered facilities particularly the tele consultation services with ophthalmologist from base hospital. On behalf of LEpra Society & MNC, he expressed his gratitude to SEVA Foundation for the support and advised staff to work hard in bringing eye health awareness in the community and also in providing quality services. The Vision Centre at Reamal of Deogarh district was inaugurated on 9th July 2024 in the presence of Sri Tankadhar Nayak, President, Lions Club, Sri Shambhulal Arawal, Secretary of Lions Club and Sri Bibhu Prasad Baliarsingh, Hospital Administrator, MNC, LEpra Society. On 22nd July 2024, the Vision Centre at Rairakhol of Sambalpur district was inaugurated by Sri Sibrām Sahu, Chairman of Notified Area Council. All the dignitaries participated in the inaugural functions praised MNC-LEpra Society and SEVA Foundation for developing opportunities to avail quality eye care services by the underserved people at their own doorstep. 170 people attended for screening on the inaugural days of above mentioned vision centres. All these three vision centres were equipped with tele ophthalmology system and used for 5 patients on the days of inauguration. Free distance and reading glasses were distributed among the identified refractive error patients and people needing surgical intervention were referred to base hospitals.





Diabetic Retinopathy and Glaucoma screening camp:

Diabetes is rapidly emerging as a major health care problem in India. Diabetic Retinopathy is a complication of diabetes that damages the retina, the light-sensitive tissue at the back of the eye. Diabetes affect the blood vessels of the retina. It will lead to blindness. Diabetic retinopathy is often symptom less until the late stage. There is no medical treatment for diabetic retinopathy. Vision loss cannot be regained. Eye is a window to see the status of blood vessels. All diabetes can diabetic retinopathy so periodical eye check-up is mandatory.

Glaucoma, known as a sneak thief of eyesight, is one of the most sight threatening condition of the eye. It usually occurs among the people above 40 years of age especially who have a family history of glaucoma. It is caused due to excess build-up of fluid inside the eye, which in normal case, is drained in blood stream. The fluid exerts pressure on vital parts of the eye like optic nerve and causes irreversible damage affecting initially field vision.

In both context, early detection and timely treatment may prevent vision loss. So, MNC conducted awareness and screening camp for Glaucoma and Diabetic Retinopathy in collaboration with Marwari Yuva Manch at the town hall of Boudh.

76 people were screened at this camp, identified 6 patients with diabetic retinopathy, 3 patients with glaucoma and 6 cataract patients. They all were referred to base hospital for higher level interventions. Further 10 people identified with refractive error were provided spectacle at the camp site.



Support of Verity Knowledge Solutions Pvt.Ltd to MNC:

MNC, LEpra Society had submitted a proposal to Verity Knowledge Solutions Pvt.Ltd for supporting a bus for patient transportation and a diagnostic equipment namely A-Scan to be utilised in OPD for patients. Fortunately, the proposal was approved and the grant was provided by the above mentioned corporate agency to procure the proposed items. On 8th August 2024, Ms. Srishsa Dassri, Director and Mr. S.K. Abdul Muqueem made a visit to Mahanadi Netra Chikitsalaya and dedicated the patient transportation bus and A-Scan for public service in an inaugural ceremony at the MNC campus in the presence of Mr. P Omprakash (Head Finance & Operation, LEpra Society), Dr. Devendra Kumar Sahu (Medical Superintendent), MNC staff members and few local invitees. Dr. Devendra Kumar Sahu on behalf of MNC and LEpra Society, expressed his gratitude to Verity Knowledge Solutions Pvt. Ltd. for its kind gesture and support that will benefit thousands of poor visually impaired patients.





23rd Advisory Committee Meeting:

Mahanadi Netra Chikitsalaya, LEPRASociety conducted its 23rd Advisory Committee meeting on 20th August 2024 at Hotel Empire, Bhubaneswar. The meeting was chaired by Ms. Meena Gupta, former Health Commissioner, Government of Odisha. All the members appraised the progress under decisions taken in the last meeting and suggested possible actions against different challenges discussed in the meeting. Sri Jagadish Pradhan, Chairman, LEPRASociety has attended the meeting as special guest.

Door to door Visit by MNC, Jharsuguda:

The team of MNC, Jharsuguda conduct door-to-door visit to screen people at their households and find out cataract cases and provide transport supports for their surgeries at the base hospital (Satellite centre of MNC) located at Jharsuguda, Odisha.



New Project:

A new project was initiated during this quarter after signing MoU with Operation Eye Sight Universal to prevent avoidable blindness by addressing refractive errors and cataracts in Jashpur district of Chattisgarh. The MNC Sattelite Hospital, Jharsuguda will be the referral hospital for performing cataract surgeries of identified cases from this area. This is a small and short duration project. The project Staff have been to Raipur for training on implementation procedure.



Review & Planning meeting was conducted at Jharsuguda Satellite Centre. After the review of last quarter, targets were set for next quarter. Staff were oriented on outreach, IEC/BCC during household visits and community discussions and maintaining qualities in activities and services. Audio-visual (film on eye health), posters and pamphlets were provided to the team for use.

Outreach Screening Camps by JNC:

In collaboration with YAR (a local NGO) and Baristha Nagarika Mancha, Khariar, Junagarh Netra Chikitsalaya (JNC) had organized a free Eye Screening camp at BEO Office of Khariar, Nuapada district on 21st July 2024. Srimati Puspanjali Nanda, Chairman of Khariar Block had attended as chief guest with other guests namely Sri Dolamani Barik (President, Baristha Nagarik Mancha), Sri Mahendra Kumar Joshi (President, YAR), Dr. Majhi and Dr. Rebati Hash from Boden Primary Health Centre. 97 people with eye health issues were screened in this camp and out of them 39 people were identified with cataract. They all were transported to JNC and provided free services that include transportation, tests, surgery, medications and spectacles.

On 18th July 2024, a mega eye screening camp was conducted by JNC for three days at Jaring Gram Panchayat Office of Junagarh block in collaboration with Indian Potas Limited and Rice Foundation. In this camp, 200 people were screened and 20 were identified with cataract and they all were provided surgery services at JNC.

In collaboration with Junior Chamber International (JCI), JNC-LEPRA Society had conducted a free eye screening camp at Tulasi Diagnosis Centre, Junagarh on 8th August 2024. All the staff JCI had supported this programme. Mr. Swammy Reddy also attended the inaugural session of the camp on behalf of LEPRA Society as Chief Guest. Above 85 people attended the camp and screened. Among them, 5 individuals identified with cataract were referred to the base hospital for free surgery and 45 individuals identified with refractive errors were prescribed spectacles with due counselling for regular use of spectacles.

In collaboration with Netram Foundation, JNC-LEPRA Society conducted a free eye screening camp at Khairamal, Bhawanipatna block office on 4th September 2024. 80 people were screened at the camp site. 15 people identified with refractive errors were prescribed spectacles and 15 people identified with cataract were provided free cataract surgery services at the base hospital.





Screening Camps for People with Disabilities:

District Social Security Office had organized Bhima Bhoi Samarthya Sibir for the people with disabilities on 25th July 2024. JNC had been invited for the eye screening of participants with disabilities. 27 people with disabilities were screened and out of them 7 screened with refractive errors and 3 screened with cataract. Free spectacles were provided to identified 7 cases with refractive error and 3 cases identified cataract were sent to JNC and were provided cataract surgery services.

JNC had conducted two eye screening camps in September for the people with disabilities at Sanyasi Kundamal of Junagarh block and Supada of Koksara block respectively. Total 48 people with disabilities had attended the camps. Among them 10 individuals identified with refractive errors and 9 individuals identified with cataracts. All the identified cases were provided free spectacles and cataract surgery services.

ASHA Training:

The technical team of Junagarh Netra Chikitsalaya had provided training to 48 ASHA workers on 22nd August 2024 at the Kesinga Hospital. Under this programme, ASHAs were oriented on eye health issues, identifying cataract cases, referrals including their roles and responsibilities in preventing blindness and visual impairment in communities. Also discussed on 21 types of disabilities and sensitised ASHAs to prioritise in reaching people with disabilities and facilitate services for their health issues.

A training programme was organised by JNC-LEPRA Society for 60 ASHA workers on 21st September 2024 at Community Health Centre of Komana Block of Nuapada district. Medical Officer of Community Health Centre and Block Programme Coordinator also had attended the programme as Guests.



Sensitisation Programme:

JNC has been sensitizing youths to encourage them in spreading eye health messages in their respective households as well as in the communities and also support screening programmes at different places. A sensitization programme on primary eye health for the student volunteers under NSS, YRC and NCC was organized at Koksara Snatak Mahavidyalaya on 9th August 2024. 45 students and all teachers have participated in this sensitization programme. Sri G Swammy Reddy from LEPRA Society had attended the programme and sensitized participants on eye problems, its impacts and the roles of teachers and students in mitigating eye health issues in the communities.

On 5th September 2024, in collaboration with Marwadi Mahila Sangh an eye health awareness and debate competition had been conducted at Priyadarshini Mahavidyalaya, Junagarh.

Urban Eye Health Project is implemented by LEPROA Society supported by Sightsavers. Under this project, we are implementing two vision centres integrated in Government Health System: one is at Capital Hospital and the other one is at Pokhatiput PHC.

The other activity is Mobile Eye Screening Van that covers Bhubaneswar and Cuttack cities targeting vulnerable groups such as slum dwellers, construction workers, industry workers, transgender and people with disabilities. The mobile van is equipped with all screening equipment including fundus camera for screening diabetic retinopathy.

The achievements have been described separately in the table left side under vision centres' indicators and mobile van Indicators.

On 22nd August, a **Glaucoma Screening Camp** was organized at Pokhariput UPHC. The camp aimed to provide free comprehensive screening focussing glaucoma, along with blood sugar and blood pressure tests. A total of 86 individuals attended the camp for screening that include 48 males and 38 females. 48 individuals tested for sugar level and 80 individuals tested for blood pressure levels. 36 individuals with diabetes were screened for diabetic retinopathy with fundus photography. 84 individuals underwent NCT test for glaucoma. 2 patients were identified with the risk of glaucoma referred for further intervention. 2 individuals identified with cataract and referred for surgery.



On 9th August at Palaspally, an **outreach camp** was conducted. 51 individuals including 9 males, 6 females, and 36 trans-genders were screened. 16 people were identified with refractive errors including 2 males, 3 females, and 11 trans-genders. 10 cases including 5 trans-genders among them received free spectacles. Additionally, 4 trans-genders were provided with lubricant eye drops. One female identified with cataract, referred for surgery. 2 trans-genders diagnosed with other eye problems were referred for further treatment.



Prevention of Vision Impairment and Blindness can contribute to the Sustainable Development Goals:

Vision makes an important contribution to the 2030 Agenda for SDGs listed by UN. The Lancet Global Health Commission on Global Eye Health had conducted an in-depth analysis and concluded: improving access to eye health services will contribute to achieving many of the SDGs. Because without proper vision and eyesight, the people remain at a lack in contributing their bit towards any development agenda".

The SDG 3 (Good Health and wellbeing) is directly linked to eye health as poor eye health has a direct link to increased mortality, lower levels of well-being and higher rates of depression. Other major goals that are also directly or indirectly impacted by the nature of eye health of the people:

- SDG 1 (No poverty): 90% sight loss occurs in low and middle-income countries
- SDG 2 (Zero Hunger): Unaddressed vision impairment traps people in poverty and leads to hunger and malnutrition.
- SDG 4 (Quality Education): Children with vision impairment have poorer educational outcomes and are more likely to be excluded from schools.
- SDG 5 (Gender Equality): Women have worse access to eye health services and are 12% more likely to suffer sight loss than men.
- SDG 8 (Decent Work and Economic Growth): Vision impairment and related discrimination stop people accessing or performing quality work and results in lost economic productivity locally, nationally and globally.
- SDG 10 (Reducing Inequality): Women, people with disabilities, indigenous people, refugees and migrants are affected by poor eye health.
- SDG 11 (Sustainable Cities and Communities): Poor vision increases the risks of road traffic deaths and injuries affecting millions around the world- impact.



An Impact Story:

Rabali Mallick, aged around 58 years and was a native of Keranmaha village under Baliguda block of Kandhamal district, Odisha. In the Tribal pockets of Kandhamal district, women remain more active and burden greater family responsibilities in comparison to their male counterparts. Rebili was engaged in turmeric cultivation. Kandhamal is famous for its local turmeric renowned as 'KandhamalHaldi' which has earned the Geographical indication (GI) tag from Intellectual Property India, an organization functioning under the auspices of the Ministry of Commerce and Industry (India). This was an opportunity for Rebili and women like her. Rebili was considering herself as a proud housewife and supporting her family financially.

But, when her vision started diminishing day by day, she faced real challenges in executing the field works which had direct implication on her family financial health. She became dependant on others for many works and the condition gradually reduced her income and health that affected her family economy and daily living. Because of ignorance, she visited traditional healers but, the efforts were in vain. She had no idea about where to go for any treatment.

The pain & plight of Rabali was brought to the notice of the Vision Centre staff by the local community volunteer and after getting information, the staffs went to Keranmaha village. During their visit, they had found Rabali Mallick in a precarious condition. As Rabali was suffering with senile cataract in her both eyes, they facilitate transportation of Rabali to Mahanadi Netra Chikitsalaya for surgical intervention. After requisite investigations and finding her surgical fit, she was admitted and undergone surgery in her Right eye. Her post-operative vision was found to be very good.



After a month of vision restoration, when our staff met Rebili, she had already regrouped herself and started work in her turmeric field to regain her income. She was very happy as she was once again independently managing her daily activities. This cataract surgery restored her vision and contributed towards the well-being of herself and her family. Now she is ready for the surgery on her left eye.
